Greetings:

The City of Waverly is a nonprofit local government entity providing essential operations and services to a citizen population of just over 10,000. There are approximately 75 full-time and an estimated 100 part-time and seasonal employees working with an annual operating and capital budget of approximately \$30.1 Million. Areas of service include police, fire, ambulance, library, parks, vegetation management, golf course, swimming pool, cemetery, economic development, community development and zoning, finance, human resources, legal, administration, and legislative. Other operations include engineering, airport, streets, water and wastewater operations, sewer operations, solid waste collection, recycling, and yard waste.

The City of Waverly completed the Youth Ball Diamonds, several staff changes happened this year with movement for some current full-time employees and also with new hires, city staff began the process of working with UKG for human resource online management, and the City purchased the Waverly Golf and Country Club to own and operate with City staff.

Two challenging topics this year were completing the budget preparation process given various new legislature changes and purchasing equipment with extended lead times and rising costs.

We challenge ourselves daily to maintain fiscal stability and to continue to look at multi-faceted budgeting philosophies and revenues.
