



DEAR ARTIST:

You are invited to apply for the 16th annual Art Walk, Waverly's juried fine arts and crafts show. Art Walk will be held in the picturesque riverside Kohlmann Park, Saturday, May 1, 2021, in downtown Waverly, Iowa. Art Walk is co-sponsored by Waverly Leisure Services and the Waverly Chamber of Commerce. Cash prizes will be awarded on the day of Art Walk after evaluation by a panel of judges. An indoor backup location will not be used in the case of inclement weather due to COVID-19 recommendations for large indoor gatherings. We will again have an optional virtual component to the show on our Facebook page in the case of an in-person cancellation.

ENTRIES & ELIGIBILITY: Please complete the form below and return with three examples of your current work. Artwork samples may be emailed to waverlyartwalk@gmail.com. Include a self-addressed stamped envelope if you would like your samples returned, and note if we are able to use images of work in our publicity. Artwork must be completely original, designed and made by the applying artist. Artists may only display and sell original artwork in the category in which they are accepted and must be present for the duration of Art Walk. Two-dimensional media including oils, acrylics, watercolors, and other painting or drawing media, photography, relief, intaglio or silkscreen, and giclée prints. Also, three-dimensional media including ceramics, jewelry, fiber, wood, glass, paper, basketry, cast iron, wrought iron, plaster and other sculpture materials are accepted.

FEES: All entries require a \$65 non-refundable booth reservation fee (12'x12'). Booth assignments will be given on the day of the show. Limited double booth spaces (24'x12') are available and require a \$110 reservation fee. Application deadline is Monday, March 29. Late entries will be considered if space allows, and will require a \$75 non-refundable booth reservation fee for single booth spaces or \$120 for double booth spaces.

COVID-19 PRECAUTIONS: We are requesting that all participants use a face covering for the duration of the show. We will also be requesting the use of face coverings of patrons and volunteers for the safety and health of all. Hand-sanitizing stations will be available in multiple areas of the park, but we also recommend that you provide your own and encourage social distancing within your booth space. Booths will be spread out more than normal and we are working on a layout that will relieve congestion of patrons. We appreciate your cooperation and understanding.
