7. Report of City Funding on Flood Public Assistance Projects and Discussion of City Flood Recovery Assistance Program.

City Administrator Dick Crayne reported:

- City staff contacted nearly all of the people on the flood buy out list in an
 attempt to insure their safety during the upcoming winter months. He further
 stated that contractors had been contacted regarding delays for those waiting
 for services to be completed such as furnaces being installed. The contractors
 informed City staff they were not waiting on equipment, however, the delays
 were caused due to work loads.
- The President amended the declaration to state that FEMA will pay for 90% of all categories of Public Assistance Work.
- The Governor has announced the remaining 10% will be covered by the State.
- It is being proposed that \$300,000 originally intended to be used for City local match in repairing public infrastructure now be utilized to assist residences and businesses.
- Potential funding through Community Development Block Grant (CDBG) and Economic Development Administration (ADA) programs for mitigation projects.

City Engineer Mike Cherry further reported:

- Graphing completed "in-house" demonstrated different scenarios on how future flooding might impact various areas of the City. The graphing will be made available on the City's website later in the week and will be utilized by the Public Works Department.
- Propose that Stanley Consultants prepare mapping that would help provide information for rising water levels in 1 foot increments. They would have a map available by March, 2009.
- The Emergency Operation Center is made up of 20 30 people who collectively share information and make decisions on action taken during an emergency situation.

Other comments made:

- Shauna Haas is in town representing FEMA while working with State and Local governments in Long-Term Community Recovery (LTCR) and Emergency Support Function (ESF) #14.
- Any flood studies completed should include effects on regions and how changes can affect areas up and downstream from Waverly.
- Dry Run improvements have been consistent with recommendations made by the Army Corps of Engineers.
- Moody looks at community economic performance not just property values.

Possible re-evaluation of FEMA flood maps needs to be done to see if they are up-to-date considering all the development that has taken place since the current map was created.
