7. Description

This single-family house is estimated to have been built in 1900 according to Bremer County Assessor records. The house form and style are consistent with houses in Waverly built during the 1880s and 1890s in Waverly. Property transfer records show the parcel was acquired by H.B. Miller from H.A. Fahnstock in February 1885. The 1894 Waverly map shows the building in place and the Miller family appears in the 1895 lowa Census near this location but was not listed in the 1885 Census. Together this information confirms that the house was in place sometime between 1885 and 1894. A construction date of ca. 1890 is consistent with this information.

This 2-story frame house is an example of a Hipped Roof, 2-Story house form with Colonial Revival detailing. The house has a stone foundation with stucco cladding on the walls. According to the 1927 Sanborn Map, the house originally was clad in wood siding and had a different porch that spanned the full front. The house currently has a low-pitched hipped roof with a flattened peak, narrow eaves and no dormers. The flattened peak may have originally been lined by a balustrade that is no longer extant. The stucco finish was likely added at the same time that the front porch was replaced by owners J.D. and Lenore Williams with the present one; this was done in the early to mid-1950s. The front façade has a Colonial Revival design for the porch and entrance bay that projects slightly from the front wall. The flat roof has a wide cornice lined by dentils and supported by square fluted columns at the outer corners. The concrete deck is faced in brick. The classical design for the entrance has fluted pilasters that match the porch columns flanking sidelights with four lights and a tall panel below. The entablature is also lined by fine dentils and a crown molding. At the rear-west end, the house has a gable-roofed, 1-story wing with a pent-gable end. It, too, is clad in stucco and has an entrance on the south façade.

Fenestration throughout the house includes a mix of replacement single-light sash and single 1/1 double-hung windows of various sizes. On the front façade, single-light windows flank the centered entrance and on the upper level, two widely spaced, narrow 1/1 units are present. On the south façade, an angular bay window with a flat roof is present with narrow 1/1 windows on the sides and a pair of 1/1 units on the wide front. The rear wing has 8/8 double-hung windows.

A detached frame 1-story garage is located at the rear of the property west of the house. It has a low-pitched front-gable roof, single-bay overhead door, and wide wood clapboard siding. The building was constructed in 1979 according to Assessor records. The garage is considered noncontributing because of its recent construction.

Alterations: stucco (undated); porch replacement (undated).

8. Significance

The Harmon B. and Atta Miller House at 503 2nd St NW was built in ca. 1890. It is an example of a Hipped Roof 2-story house form that was modified during the early 20th century with Colonial Revival features and finishes. The house qualifies for the National Register of Historic Places as a contributing resource to the historic district under Criterion C but the garage is considered noncontributing.

Property transfer records show the parcel was acquired by H.B. Miller from H.A. Fahnstock in February 1885. H.B. Miller was Harmon B. Miller and his wife was Atta. The 1894 Waverly map shows the house where the couple resided in place and the following year the Miller family appears in the 1895 lowa Census. Harmon was 46 years old at the time having been born in Ohio; he was serving as the Bremer County Treasurer at the time. By 1899, the city directory lists him as retired. Atta Miller was 32 years old and had been born in Pennsylvania in the 1895 census. The couple had two sons, Harold and Ray.

In 1917, Harmon transferred the property to his wife Atta. Harmon passed away in 1931 and Atta in 1951. After Harmon died, Atta continued to reside here with her son, Harold W. Miller, living next door to the north. In 1950 Atta transferred the house to Bonnie Tietje and Melva Osincup, likely her daughters. The following year after Atta's death, the house was transferred to C.F. and Mary Carstensen who held it briefly reselling in 1953 to J.D. and Lenore Williams. According to local historian Mary Meyers, the Williams family had the stucco work and new porch installed sometime in the early-to-mid-1950s.


