7. Description

This single-family house is estimated to have been built in 1949 according to Bremer County Assessor records. The house form and style are consistent with the forms of houses in Waverly built after World War II and into the 1950s. This property was transferred from William and Anna Mueller to G.R. Harlan in August 1949. By the time the 1957 phone book was published, G.R. Harlan was residing here at 308 5th Ave NW. Together these public records suggest that the house was erected in 1949.

This 1½-story stucco house is an example of a Minimal Traditional house form with Tudor Revival detailing. The house has a stucco-clad concrete block foundation and stucco cladding on the walls and rectangular and diagonal narrow half-timbering. A moderate-pitched cross-gabled roof has a broad shallow projecting wing on the west half of the front façade and a small contiguous gabled entrance bay on the right side of the wing. A reddish-brown brick rectangular surround with an inset circular arch sets off the original entrance door. A matching brick is used for an exposed chimney at the west gable end. In early 2013, construction of a side-gabled addition with a stucco finish and matching half-timbering at the east end of the house is under way.

Fenestration throughout the original portions of the house includes paired 8-light casement windows. The feature window to the left of the main entrance is a variation of a Chicago window group with single 8-light casement windows flanking a large, rectangular single-light window. The front door has channel-cut construction with a small diamond-shaped window and a semi-circular upper edge.

This property has two free-standing garages. A frame single-bay garage north of the house was built in 1949 according to Assessor Records, the same year as the house. It has a front-gable roof, narrow eaves, four-light windows, and deeply textured stucco cladding that matches the house finish. A second garage is located east of the house and opens onto 3rd St NW. It has a low-pitched hipped roof with clapboard-style vinyl siding and a newer overhead door. According to Assessor records, this garage has an address of 603 3rd St NW and was built in 1923. The 1923 garage (vinyl sided) is considered noncontributing and the 1949 garage is considered contributing because it retains the original stucco finish, windows, and roof profile.

Alterations: 1923 Garage: vinyl siding (undated); overhead doors on both garages (undated); east addition on main house (2012-2013).

8. Significance

The Harlan House at 308 5th Ave NW built in ca. 1949 is an example of a Minimal Traditional house form with Tudor Revival detailing. It is typical of several other houses built in this neighborhood as in-fill housing during the years following World War II. The house qualifies for the National Register of Historic Places as a contributing resource to the historic district under Criterion C and the garage is considered noncontributing.

This property was transferred from William and Anna Mueller to G.R. Harlan in August 1949. By the time the 1957 phone book was published, G.R. Harlan and his wife Mary were residing here at 308 5th

Ave NW. The Harlans held the property until September 1961 when it was purchased by Waldemar and Esther Gies. At the time, Rev. Gies was employed as an instructor at Wartburg College. The couple held the house until May 1972 when they sold it to James and Mary Ellen Brandau.


