**New Business**

Sheriff Hildebrandt advised that Mr. Meyer is working on a possible electrolysis problem in the building which is causing blue streaking in porcelain toilets and lime like build up on the stainless steel. Meyer has leaned with the assistance of the city utilities that this problem may be coming from an insufficient ground on the water system. Mr. Meyer will continue to explore and recommend a solution.

Sheriff Hildebrandt presented monthly bills which included the annual billing for custodian and .5 records clerk. Mr. Reuter moved to approve as presented, 2<sup>nd</sup> by Mr. Boorum. All present voted aye; motion carried.
