Chairman Hinderaker called the meeting to order at 0900 on Monday, September 14, 2009.

Mr. Boorum moved to approve the agenda, 2nd by Mr. Clemen. Carried

The minutes of the August meeting were reviewed. Mr. Clemen moved to approve, 2nd by Mr. Ribich with a correction that Clemen/Boorum made the August meeting to adjourn motion. All present voted aye; motion carried. Sheriff Hildebrandt presented the treasurers report. Mr. Kammeyer moved to approve, 2nd by Mr. Clemen. All present voted aye, motion carried.

Old Business

There was no new development on storage building.

Chief Pursell reported CodeRed test went well with Tripoli today. Sheriff Hildebrandt reported that the all call done on August 18 went well with 12,012 calls made and 5840 connected for 48.6 connect rate. Sheriff Hildebrandt reported that time of day likely factored into this low connect rate. Total minutes used for this test was 3,577 which is a good measure of how often Code Red can be utilized during a year. Chief Pursell advised he had a few people with concern that the calls for CodeRed come from an 866 number and asked if they could display as a local number? Mr. Ribich asked if CodeRed could be used for power outages. Mr. Ribich also asked if a list could be compiled for emergency notifications for the medically needy such as those requiring oxygen. Chief Pursell and Sheriff Hildebrandt will look into establishing such a contact list. Also, Sheriff Hildebrandt will check on the question of the 866 number with CodeRed.

Sheriff Hildebrandt advised the board that installation of mobile data solutions is being completed and startup could be as soon as the end of September or early October.

Sheriff Hildebrandt advised Mr. Kehe will keep the police department stairwell walls open until the next significant rain to determine if the leak has been repaired.

New Business

Chief Pursell asked the board on direction for the alley exit from the west law center parking lot. The alley has a major blind spot for drivers looking left and an employee vehicle was struck by two bicycles on the sidewalk upon exiting the alley. Mr. Boorum moved to get a quote for installing a "red light signal system", to warn cyclists and motor vehicle operators of oncoming traffic, 2nd by Mr. Clemen. All present voted aye; motion carried.

Sheriff Hildebrandt advised the board that next years budget will require a major equipment item to upgrade the recording device for the video security equipment at the law center; if done today the equipment would cost approximately \$26,543.00.

Sheriff Hildebrandt presented a list of monthly bills. Mr. Boorum moved to pay bills as listed, 2nd by Mr. Ribich. All present voted aye; motion carried.

Chairman Hinderaker set the next meeting for Monday, October 12, 2009 @ 0900.

Mr. Boorum moved to adjourn, 2nd by Mr. Ribich. Carried.
