**Old Business**

Chief Pursell advised the board that he and Sheriff Hildebrandt visited six perspective sites for a storage facility on land owned by the city of Waverly. Chief Pursell and Sheriff Hildebrandt recommended further exploration of two sites; well site number 7 on east side of Waverly and south industrial park. Chief/Sheriff will research those sites.

Mr. Neil moved to appoint Jay Ranard to two year term as at-large representative on the Bremer-Waverly Law Enforcement Board, 2<sup>nd</sup> by Mr. Kammeyer. All present voted aye; motion carried.

Sheriff Hildebrandt presented budget reduction of \$9,000 which is the savings from transferring CodeRed to Emergency Management. Mr. Kammeyer moved to accept budget reduction, 2<sup>nd</sup> by Mr. Neil. All present voted aye; motion carried.

**New Business**

Sheriff Hildebrandt recommended increasing the storage in the building security system to 1TB at a cost of \$775 so more storage could be gained at a better quality. Mr. Kammeyer moved to approve purchase, 2<sup>nd</sup> by Mr. Ranard.

All present voted aye; motion carried.

Sheriff Hildebrandt presented a list of monthly bills to be paid. Mr. Kammeyer moved to pay as presented, 2<sup>nd</sup> by Mr. Neil. All present voted aye; motion carried.

Chairman Boorum set the next meeting for Monday, April 11, 2011 at 0900.

Mr. Kammeyer moved to adjourn. Carried.
