

CITY OF WAVERLY
LEISURE SERVICES DEPARTMENT KEG BEER PROCEDURES
Reference - Waverly City Ordinance 589 11-21-88 Resolution Number 88-40

PROCEDURE: Any person wishing to conduct a kegger in any area to which this applies shall notify the Leisure Services office at least one working (24) twenty-four hours in advance and comply with the following procedure:

- A designated agent shall be named who shall sign a responsibility agreement as stated later in this regulation.
- A designated agent shall be available for personal contract by City Officials at all times during the kegger.
- The designated agent shall pay a keg permit fee of \$30.00 and a shelter reservation of \$35.00 which is non-refundable. In addition, the agent shall pay a deposit of \$50.00 per keg by check, cashier's check, or cash, to be held by the Leisure Services Department as a damage deposit. The Leisure Services personnel will designate the area in which the kegger is to be conducted.
- The agent shall assume responsibility to assure that all State laws are complied with in the conduct of persons attending the kegger and that the area used for the kegger is left in a clean and litter free with no property damaged beyond the extent of normal wear and tear.
- Conducting and continuation of the kegger shall be contingent on the persons involved complying with all applicable state and city laws.
- Upon completion of the permit application, a copy of the permit will be forwarded to the Chief of Police for their notification of time, date and place of the kegger.
- Deposit disposition. The \$50.00 deposit required shall be refunded within 14 days in full or on a pro-rated basis depending on the condition in which the site is left after the kegger is held.
- If it is necessary for the Leisure Services Department personnel to clean-up the area or repair any damage beyond ordinary wear and tear, a log of the time spent on such clean-up or repair shall be kept. The damage deposit refund shall be reduced by an amount equivalent to the applicable hourly wage of the employees for the time necessary to clean the area of repair the damage. Cleanup should be started by 9:00 a.m. the day following the event.
- The deposit is not to be construed as a limit of liability for damage to city or public property. The department may take any legal action necessary to recover additional damage.
