Documents will also be available electronically through Master Builders of Iowa (MBI), the Iowa League of Cities, and through Beeline and Blue's Online E-plan Room.

Each bid shall be accompanied by a bid bond, certified check, cashier's check, or certified credit union share draft in a separate envelope in the amount equal to five percent (5%) of the total amount of the bid. A Pre-Bid Conference will be held at 1:00 PM on Tuesday, September 26, 2023, at the Waverly Public Library at 1500 W. Bremer Avenue, Waverly, Iowa, 50677.

The City of Waverly, Iowa, will hold a public hearing at 7:00 PM, on September 18, 2023, in the Council Chambers, City Hall, Waverly, Iowa. At said hearing any interested person may appear and file objections thereto or to the cost of the improvements. At the hearing, the City will receive and consider any objections made by any interested party, to the Plans and Specifications, proposed form of Contract, and the estimate of the cost for the project.

Lump-sum bids with Alternates will be received under one contract as described in the specifications. Bid opening will occur on Tuesday, October 10, 2023, at 3:00 PM where bids will be publicly opened and read aloud. Bids received will be reviewed by the Library Board on Tuesday, October 10, 2023, at 5:00 PM during a regularly scheduled board meeting. Recommended bids will be acted upon by the City at the time and place specified below or at such later time and place as may then be fixed. Recommended bids will be presented to the City Council of Waverly, Iowa and considered at a meeting presided over by the Mayor, to be held in the Council Chambers, City Hall, Waverly, Iowa, on November 6, 2023, at 7:00 PM.

The scope of the project includes refinishing of various portions of an existing 21,200 SF singlestory, library building (with partial basement) and an addition of a 1,200 SF teen center.

Refinishing includes, but is not limited to, installation of new carpeting & base trim, removal and partial replacement of wall vinyl, skim-coating of walls, re-painting, modifications to existing book shelving systems and end panels, new study rooms, children's tiered seating, baby garden/toddler play area, adult den with fire place, modifications to the drive-through pickup window, and removal and installation of new check-out desk, help desk, and youth desk, along with the removal of bulkheads and installation of new signage halos above service desks.

The new teen center includes, but is not limited to, new built-in storage seating & gaming center millwork, overhead garage door, windows, HVAC equipment, electrical & telecommunications services, and lighting.

All bookshelves, book-bins, standalone desks, desk chairs, cubicles, lounge chairs, benches, booths, side tables, DVD/CD racks, book displays, filing cabinets, rolling-carts and other furniture are existing. Each component listed above shall be removed and re-installed under a separate contract between the City of Waverly (on behalf of the Waverly Public Library) and Library Furniture International (LFI), located at: 1945 Techny Road, Northbrook, Illinois 60062.

The contractor is responsible for coordinating with LFI and the Waverly Public Library to determine the project's overall timing, schedule, and phasing.
