- 2) **Approval of Meeting Minutes** Correction in December Minutes under Item 4. Rental rate is \$178.00/hr wet with instructor. \$59.00/hr for the instructor. Motion to approve December Minutes with correction made by Lee Hinrichs, seconded by Eric Bagelmann. Approved.
- 3) **Review Financial Report and Approve Bills** No new bills to approve. Motion to approve Financial Report made by Eric Bagelmann and seconded by Lee Hinrichs. Approved.

- 8) **Project Status Report** No new information to report.
- 9) **Group Discussion** Cedar Valley Business Magazine Article January 2019 issue spot lighting the pilot shortage threatening regional airports and its impact on Iowa. Briefly, the shortage is of professional pilots, those holding Commercial and ATP (Air Transport Category) licenses. Iowa DOT Office of Aviation states the impact the

aviation industry has on lowa's economy is \$2.1 billion in payroll. Group discussed what some of the problems being faced are and what can be done about them. Tim Busch, Chief Flight Instructor for lowa Flight Training, provided good input on current flight training, issues he faces and solutions he uses. One being using computer based training to reduce the cost to a student saving several thousands of dollars. Problem is getting younger people interested in the aviation industry as a potential career. Anelia, from the Waverly Newspaper, will be contacted for a possible human interest story. It was also agreed that the Airport needs to get information to City Council and the public about what this airport means to this community. More discussion is needed.
