A Regular Meeting of the Waverly City Council was held on September 9, 2019 at 7:00 P. M. at City Hall. Mayor Soash presided.

- A. Mayor Soash called the meeting to order.
- B. Roll Call
  - Present: Birgen, Drenkow, Kangas, Sherer, and Waldstein Absent: McKenzie, Rathe
- C. Mayor Soash led in the Pledge of Allegiance.
- D. Moved by Drenkow, seconded by Birgen to approve agenda as presented.

Motion passed. Yes: 5 No: 0 Absent: 2

- E. Moved by Drenkow seconded by Birgen to approve the August 19, 2019 regular meeting minutes.

  Motion passed. Yes: 5 No: 0 Absent: 2
- F. Council welcomed Len Jentz as Guest Councilperson for September and Mayor Soash announced that the Pizza Ranch, Inc. awarded its community impact award to Mr. Jentz.
- G. Public Hearing
  - 1. This was the date, time, and place for a public hearing on Ordinance 1065, an Ordinance adopting the Policy Statement, Connection Fee Schedule, and Connection District Plat for East Bremer Sanitary Sewer Extension 2019 Project.
    - There were no oral or written public comments.
    - The public hearing was then closed.

Moved by Sherer, seconded by Birgen to approve the Second Reading of Ordinance 1065, an Ordinance adopting the Policy Statement, Connection Fee Schedule, and Connection District Plat for East Bremer Sanitary Sewer Extension 2019 Project.

- City Attorney Bill Werger informed Council that Nutrient Ag will divide the south lot into two lots and the new lot on the east will then need City sewer service.
- 2. This was the date, time and place for a public hearing on the proposed Amendment No. 5 to the Waverly Unified Urban Renewal Plan in the City of Waverly.
  - There were no oral or written public comments.
  - The public hearing was then closed.

Moved by Drenkow, seconded by Birgen to approve Resolution 19-137, a Resolution determining an area of the City to be an Economic Development area, and that the rehabilitation, conservation, redevelopment, development, or a combination thereof, of such area is necessary in the interest of the public health, safety or welfare of the residents of the City; designating such area as appropriate for urban renewal projects; and adopting Amendment No. 5 to the Waverly Unified Urban Renewal Plan.

• City Attorney Bill Werger explained that the City's urban renewal plan is the document that determines what the City can spend the tax increment financing (TIF) money on. Often, TIF money is used to help cover costs of infrastructure including streets, sewer lines, and water lines. TIF is determined by the increment in value increase that occurs by doing a project on one particular property. The City borrows money for a particular project and repays the loan amount with the tax increment revenue. The City holds a consultation with the School and County to receive input from them. Agricultural land owners' consent is also asked for. The increment is not on the base tax for a property it is what is generated by the development or re-development of a property. If the

increment is not all used in a given year, it is distributed between the taxing authorities. Generally, the increments sunset anywhere from 10 to 20 years.

2a. Moved by Kangas, seconded by Birgen to approve the First Reading of Ordinance 1066, amending the current Waverly TIF Ordinance 1060 in connection with the adoption of Amendment No. 5 to the Waverly Unified Urban Renewal Plan.

    - City Attorney Bill Werger explained to Council that while Waverly Senior Housing reports to the Municipal Housing Commission. Waverly Senior Housing has saved enough money in their reserves to pay for this project. The City of Waverly

needs to approve large expenditures.

## K. Regular Business.

Moved by Birgen, seconded by Waldstein to approve Resolution 19-140, a Resolution approving the Iowa Northland Regional Transportation Authority's Transportation Alternatives Program (TAP) Programming Agreement for the Rolling Prairie Trail Extension in Waverly, Iowa along 10<sup>th</sup> Avenue SW from Heritage Way (IA 3) to 16<sup>th</sup> Street SW.

- TAP funding is distributed by Iowa Northland Regional Council of Governments for the region. The money is given by the State to be used on projects that are deserving of the funds. Funding for this project was awarded to the City by INRCOG. TAP funding only covers construction expenses; it does not include engineering expenses. This is a regional policy that is agreed upon. The State Recreational Trails Funding does allow funds to be used for engineering, design, construction, and administration and would be an additional \$35,000 in funding. If we are awarded State Recreational Trails funding, the TAP funds will go back into the pool of funds available for other regional projects, and the fiscal year 2020-21 capital improvement projects would, in turn, be reduced by approximately \$35,000.
- 2. Moved by Drenkow, seconded by Birgen to approve Resolution 19-141, awarding the Citywide Asphalt Patching-Fall 2019 project to Heartland Asphalt of Mason City, Iowa for the bid amount of \$46,170.13 and authorizing the City Attorney to review and approve the Performance and Payment Bonds.
