A Regular Meeting of the Waverly City Council was held on October 21, 2019 at 7:00 P. M. at City Hall. Mayor Soash presided.

- A. Mayor Soash called the meeting to order.
- B. Roll Call
 - Present: Drenkow, Birgen, McKenzie, Rathe, Sherer, and Waldstein Absent: Kangas arrived at 7:09 p.m.
- C. Moved by Drenkow, seconded by Birgen to approve agenda as presented.

Motion passed. Yes: 6 No: 0 Absent: 1

D. Moved by McKenzie, seconded by Birgen to approve the September 23, 2019 study session minutes.

Motion passed. Yes: 6 No: 0 Absent: 1

- E. Employee Limelight

H. Regular Business

Councilmember Kangas arrived at 7:09 PM.

1. Moved by Rathe, seconded by Birgen to approve Resolution 19-161, Approving the purchase of property located at 517 3rd Street SE from Phil and Molly Fitch for the sum of \$135,000.00.

Motion passed. Yes: 7 No: 0 Absent: 0

- If the City decides to purchase the house, it may be demolished, moved somewhere else or something else may be done with it. Since the property will not be used for at least one-year or more, the house will be very rentable. The purchase is beneficial regardless of the outcome of the 3rd Street SE bridge. The house is not necessary to do the project; however, it would be convenient for large equipment during the construction.
- It is appreciated that Staff brought this purchase option to Council. The bank was willing to offer the same interest rate as the sellers have at 3.25% with about \$100 in fees. Staff would be encouraged to reach out to non-profits that need transitional housing to see if the house could be utilized in that manner. Although supportive of this purchase, purchase would not mean a commitment for a bridge project. It has, however, been a topic of high priority to decide the future of the bridge.

- City Attorney Bill Werger confirmed with the City's Human Resource Manager Abby Meester that the language in this policy is consistent with the language in the employee manual.
- Since the City received the grant, the resolution is a requirement in this process. Rose Phillips of Iowa Northland Regional Council of Governments (INRCOG) informed Council that although we may have the same policy in the employee manual, the funding source requires this, so we have to do it.
- 3. Moved by Rathe, seconded by Birgen to approve Resolution 19-164, Adopting a Residential Anti-Displacement and Relocation Assistance Plan for the City of Waverly, Iowa.

4. Moved by Sherer, seconded by Drenkow to approve Resolution 19-165, Adopting an Excessive Force Policy for Waverly, Iowa.

• INRCOG's Rose Phillips noted that the definition of excessive force is not stated in the policy.

5. Moved by Drenkow, seconded by Birgen to approve Resolution 19-166, Adopting a Lobby Policy Governing the Lobbying of Housing and Urban Development Personnel and/or Department of Commerce Personnel.

6. Moved by Kangas, seconded by Birgen to approve Resolution 19-167, Adopting an Affirmative Fair Housing Policy for the City of Waverly, Iowa.

Motion passed. Yes: 7 No: 0 Absent: 0

- No previous policy was found. Sexual orientation is covered within the Civic Rights Act.
- 7. Moved by Drenkow, seconded by Birgen to approve Resolution 19-168, Adopting a Procurement Policy for the City of Waverly, Iowa.

8. Moved by Drenkow, seconded by Birgen to approve Resolution 19-169, Adopting a Code of Conduct for the Officers and Employees of the City of Waverly, Iowa.

Motion passed. Yes: 7 No: 0 Absent: 0

- Council is covered under this policy as officers of the City. For instance, if a sibling of a Councilmember came to Council to bid on this project, the Councilmember would need to abstain from voting. Looking at the application, it is supposed to be for those people who are engaged in the award or administration of the contracts supported by the federal grant. Fraud, waste, and abuse is regarding what is happening in regards to this grant. This is very broad.
- 9. Moved by Drenkow, seconded by Waldstein to approve Resolution 19-170, Approving a plat of survey combining the four existing parcels into two, Parcel OO and Parcel PP for the properties located at 2103 E. Bremer Avenue for Hanawalt United, LLC.

- 11. Moved by Rathe, seconded by Waldstein to approve Resolution 19-172, Accepting the Living Roadway Trust Fund (LRTF) grant funds up to \$10,000.00 to be used towards the purchase of a Utility Task Vehicle (UTV) for the Vegetation Management Division with a City match of \$2,900.25.

- The passage of this resolution will cause the release of funds for this grant. This grant is not hard to receive. There are fewer than ten cities in Iowa with a Vegetation Management position. Waverly is the smallest city with this position. There are still more funds available. The position seems to be well-fitted for Waverly.

Moved by Drenkow, seconded by Waldstein to approve Resolution 19-173, Accepting the Living Roadway Trust Fund (LRTF) grant funds up to \$1,870.40.00 to be used towards the purchase of a Utility Task Vehicle (UTV) Skid Spray Unit for the Vegetation Management Division with a City match of \$467.60.

- J. Staff Updates
 - Leisure Services Director Garret Riordan announced that there will be a Candlelight Walk on November 9 beginning at 5:00 p.m. Volunteers are needed and set up will start at 3:30 p.m.
- K. City Council Comments
 - Councilmember Rathe thanked the crew from Redeemer Lutheran Church for the Lenten project they worked on. This involved doing sidewalk improvements on Second Avenue in NE Waverly.
 - Staff informed Councilmember Birgen that the Exchange Building is nearing the completion. There are just a few items to be completed yet. The crossing signal on 8th Street NW and West Bremer was hit by a vehicle, but is in working condition once again. There is no walk/don't walk signal at 10th Street NW and West Bremer; it could possibly be replaced, however, it is limited by the controller. Birgen commented on salt trucks being named in Scotland. They are called Gritters and have naming contests for them. Mr. Birgen invites all who would like to discuss City business immediately after the Council meeting at the Beach House.
 - Staff informed Councilmember McKenzie that pink dots on fire hydrants mean that Midland GIS has surveyed them for the mapping process.
 - Councilmember Waldstein again lifted-up Sue Van Hemert by adding that while Waldstein was on the library board there were many compliments of the youth program. Waldstein was also informed that the weather is causing delays in the completion of the Cedar Lane improvements.
 - Councilmember Sherer thanked Staff for the repair made to the West Bremer Avenue intersection at 20th Street NW. Staff informed Councilmember Sherer that the Ball Diamond Task Force will present at the October Study Session on October 28 and a proposal will be brought to Council in November for a vote.

 - Staff informed Council that this is the same program as last year. Private property owners have already lined up hunters for their properties.
- L. Mayor's Comments
