• Councilmember Drenkow noted that the Waverly Senior Housing Project is now named the Red Cedar Place. This is to commemorate the Red Cedar Rail Road that had run by this area in past times.

K. Regular Business.

1. Moved by Drenkow, seconded by Sherer to approve Resolution 19-191, approving a Plat of Survey to re-subdivide the three existing lots to Lots 1, 2, and 3 for the properties located at 3401 E. Bremer Avenue for Richard Schulz.

- Planning and Zoning Commission passed this unanimously.
- 2. Moved by Drenkow, seconded by Birgen to approve Resolution 19-192, approving a preliminary plat to re-subdivide property described as Parcel ID #0917200016 into three additional lots located in the Pheasant Ridge Subdivision for Adam and Kelly Moeller.

- City Attorney Bill Werger informed Council that the one "no" vote from Planning and Zoning was due to this area being a potential future arterial road. 29th Avenue/240th Street is a potential link to Shell Rock many years in the future. There is a request to Bremer County for rezoning. Currently, the City does not have a two-mile radius 28-E agreement with Bremer County so the State law supersedes County and City. The City has looked at working with Bremer County for a new 28E agreement. Per State law, the County is required to have the City review everything within two miles.
- 3. Moved by Sherer, seconded by Rathe to approve Resolution 19-193, approving the Golf Course Fees and Charges for 2020.

Motion passed. Yes: 6 No: 0 Absent: 1

- There was good discussion at the last commission meeting about how Waverly's golf rates match up with other quality courses in the area. Some catch up needs to happen while at the same time not pricing the course out of the market. Traditionally, the course raised rates approximately every two years for season passes, yet, has not done any rate increases since 2015. The rate increase for 2017 was apparently missed in 2017. Certain passes were deliberately not increased. For example, the junior passes were not increased since we are trying to encourage more junior golfers to play. The adult +spouse prices have stayed steady since 2011.
- 4. Moved by Rathe, seconded by Sherer to approve Resolution 19-194, approving Change Order 3 for items associated with the delays caused by the Railroad Crossing Permit and to vertically extend the box culvert headwall and wingwalls to a height equal to or slightly above the bike path for the Railroad Crossing Improvements at 20th Street NW and 5th Avenue N 2018 project in the amount of a \$26,415.50 increase.

- City Engineer/Public Works Director Mike Cherry stated there are increased costs of \$17,456.00 for several items associated to the delays caused by the Railroad Crossing Permit. The price includes costs from Iowa Trenchless, Baker Enterprises, and Croell the prime contractor. This request is allowed by contract for substantial delays deemed outside the contractor's control. The \$8,959.50 price for the item is to vertically extend (approximately 18-inches) the box culvert headwall and wingwalls to a height equal to or slightly above the bike path. This price includes the removal of existing fence, forming and pouring the walls, and reinstalling the existing fence onto the new concrete. There was a change order (number 1) for a \$183,280 decrease for a planned utility duct bank that was to be installed beneath the railroad for conduit to used for telecommunications, fiberoptic, etc. This did not happen as the cost was too significant for the benefits that would have been received. Anything with steel in it is susceptible to more inflation than a cost of living increase. The completion date for the crossing gates remains unknown.

Moved by Birgen, seconded by Drenkow to approve Resolution 19-195, Fixing Date of December 16, 2019 at 7:00 p.m. in the Council Chambers of City Hall for A Meeting On The Authorization Of A Loan Agreement And The Issuance of Not To Exceed \$140,000 General Obligation Capital Loan Notes Of The City of Waverly, State Of Iowa (For An Essential Corporate Purpose), And Providing For Publication Of Notice Thereof.

- The seller/property owner for this property approached the City to find out if it was in the interest of the City to purchase this property. The City felt it would be beneficial to purchase this property to aid as a staging area during the 3rd Street SE anticipated bridge work. When the City takes on debt, there must be a public hearing.

Moved by McKenzie, seconded by Waldstein to approve the First Reading of Ordinance 1069, an Ordinance amending Chapter 100, Sections 100.5.02, 100.6.02, 100.6A.02, 100.7.02, 100.8.02, 100.9.02, 100.12.02, 100.13.03, 100.16.03, 100.18.03, and 100.28, of the Waverly Municipal Code amending the Special Provisional Uses application process to comply with the Iowa Code by making the Board of Adjustment the body that issues Special Provisional Use Permits.
