Regular Meeting Minutes – December 7, 2020 Ivan "Ike" Ackerman Council Chambers

A Regular Meeting of the Waverly City Council was held on December 7, 2020 at 7:00 P. M. at City Hall. Mayor Hoffman presided.

The Governor of Iowa has declared a Public Emergency because of the COVID-19 outbreak. The Mayor has determined that an in-person meeting of the City Council is impossible or impractical without violating the Governor's mandates.

When an in-person meeting is "impossible or impractical," Iowa Code Section 21.8 permits a governmental body to conduct a meeting by electronic means.

The meeting was conducted by video conference using ZOOM from the Council Chambers. The Mayor Adam Hoffman and City Clerk Carla Guyer were in the Council Chambers. The 7 Council members were not in the chambers, but participated via ZOOM conferencing.

Comments for items on the agenda or the Public Hearing could be made by submitting them prior to the meeting to the City Clerk, Mayor or any of the Council members or by calling 319-596-0179 during the meeting.

The video/audio conference of the meeting was broadcasted on the normal public access channels. Staff strived to maintain the quality of the video and audio during that broadcast. Public access was available through this broadcast.

Meeting minutes were kept and included a statement explaining why an in-person meeting was impossible or impractical.

- City Administrator James W. Bronner explained to Council that alternate options are sometimes listed in order to give the homeowner the full use of the grant dollars. So, if the original items bid for improvement come in lower than anticipated, they might decide it is appropriate to add further necessary improvements to the project.

City Administrator Bronner confirmed for Councilmember Birgen that City Clerk Carla Guver is named as the director liaison for this commission. Councilmember Drenkow was informed that the number of terms a Commission member may serve is not limited since it is not designated within the proposed ordinance. Drenkow expressed concern for certain wording and will work with City Administrator Bronner and City Clerk Guyer on wordsmithing the ordinance for the 2<sup>nd</sup> reading. Councilmember Rathe voiced that this is a really good first draft, and she feels good about how the goals have been narrowed down, but would like to see goals added that provides education for the Commission and Council for various topics. In her research of other cities, she found that it sometimes takes several months to hone in on the goals. She questioned whether Council needed to help the Commission with a bit of a budget for education. City Administrator Bronner added that the ordinance was left a little broad to leave flexibility for changes in goals, etc. so that it can fall under the same jurisdiction. The task force has provided a good list of goals which is somewhat of a secondary document. Councilmember Drenkow added that goals and budget requests can be brought forward to Council as part of the planning process. Task Force member Raj Patel commented that the task force was trying to keep the goals flexible so they aren't fixed with specific goals for the betterment of the task force and the community. The task force has not talked about which department the commission should fall under for long term since they are still learning what is required of the commission. City Administrator Bronner informed Council that the Commission will fall directly under the Administration Dept. Councilmember Birgen voiced that he was glad to see in the powers and duties that the Commission will be a recommending body to Council. City Administrator Bronner explained that Human Resources serves as an access point for all of the commissions based on needs, but should not be a member of the commissions. Councilmember Beaufore noted that the Commission will try and bridge the gap in activities that are currently being experienced and support the groups that are already in the community. Guest Councilmember Dr. Nana Quaicoe commented that Wartburg College is a champion in promoting diversity and inclusion. Councilmember Birgen expressed that part of the activities of the Commission would include trying to get the diverse student population to attend the activities within the community. Commission member Raj Patel suggested replacing the word "activities" with a more appropriate phrase that still allows the communication within the community and achieve the goal. Councilmember Birgen remarked that he liked that the word "promotion" was used in an attempt to promote the activities of the community. Councilmember Kangas suggested leaving the word "activities" and adding the words "and awareness", so it would refer to promoting the awareness within the community as well.

- 15. Discussion and possible action for the 3<sup>rd</sup> Street SE Bridge memorialization.
  - City Administrator James W. Bronner reviewed that Council made the decision several months ago, to have the bridge removed and demolished. Council resolved to memorializing the bridge for an amount of \$7,000. Since that time, the Historic Preservation Commission was given an opportunity to bring ideas for memorialization of the bridge. Bronner also mentioned that what Council chooses will need to be formally approved by resolution and then, approved by the Army Corps of Engineers in order to get a permit for demolition and removal.
  - Historic Preservation Commission Chair Karen Lehmann explained they are presenting four (4) diverse options with two (2) of them involving moving a span of the bridge. Lehmann reviewed the less complicated ideas: signs could be displayed, a stereoscope costing about \$10,000 could project up to six (6) different images, plaques could be placed on large stones or an art project is another idea. It is much more than just a memorialization because of the history and impact on Waverly.
  - Overall, Council seemed to like the combination of the ideas with having signage, a plaque on a stone, and a stereoscope. This combination would cost an estimated \$15,000. Fundraising for ½ of the amount was discussed. How to make fundraising happen was inquired about by the Commission. Council would also have the option to change the \$7,000 capped figure if they choose. Following discussion, Council directed Staff to prepare a resolution for formal action and Councilmember Drenkow agreed to work on this with them. The resolution will propose the type of memorialization, location of the memorialization, and what the budget

will look like for the proposed action. Council complimented the Commission on the work they did to put the menu of ideas together. Council did express their concerns for safety and effects of flooding. If the bridge were used as a gateway to Brookwood Park, it would cost more than the benefit the City would get from it. There would have to be a trail installed to connect the existing trail. FEMA would dictate what kind of structure could even be placed there. It would be nice to have more feedback from the community regarding this issue. It would be good to explore the cost of using one of the joints or possibly a portion of one of the pieces of the bridge where the bridge comes together in lieu of a post or stone. Mayor and Council thanked those who participated in bringing the ideas to Council.

Moved by Beaufore, to affirm the \$7,000 as a cap toward the memorialization of a stereoscope, signage, and a plaque. (Died for lack of second.)

Moved by Birgen, seconded by Rathe that staff put together estimated costs of memorializing the Harmon Street Bridge, a/k/a the 3<sup>rd</sup> Street SE Bridge, for a stereoscope, signage, and a plaque on a large rock.

- 16. Moved by Birgen, seconded by Rathe to affirm Resolution 20-126, a Resolution requiring face masks be worn by any member of the public while being an occupant of a public building.
  - Councilmember Schneider expressed his disappointment for the stigmatizing of COVID-19 that has occurred. He added that he has never said that it is not a dangerous disease. Schneider talked about keeping the public library closed and the amount of money the City has spent to continue to fund it. Councilmember Dr. Rathe commented that she feels like there is evidence that COVID-19 is a dangerous disease that does impact people of all ages while preying on people who are more vulnerable. People are dying who would not be dead if it wasn't for the Covid-19 virus, and she supports reaffirming the resolution. Councilmember Beaufore agreed with Schneider with how this virus has negatively impacted the lives of people. Beaufore stressed the importance of hand washing, sanitizing, public education, staying at home if you are not feeling well, and social distancing in addition to the use of face masks.

Moved by Rathe, seconded by Birgen to call the question.

The use of personal carts will be allowed with no trail fees. It is yet to be determined if the course will be open on Thursday.

- L. City Council Comments
  - Councilmember Beaufore recognized that 79 years ago this day, was the attack on Pearl Harbor. There were 2,385 service members lost that day. Appreciation for all servicemembers will be kept in our thoughts. Beaufore also noted that there will be a "Waverly Light Cruise" happening on Thursday, December 10<sup>th</sup> at 6:00 p.m. and KWAY will be playing Christmas music.
  - Councilmember Birgen congratulated the Bremer County Fair Association in making progress at their new location site and thanked all the people that helped make this happen.
  - Councilmember Glaser announced that next summer (2021), he and his family plan to sell their home and move to the Des Moines area since he now works for a company that is headquartered in Des Moines. He enjoys and is honored to serve as the Ward II Councilmember and plans to work closely with the Mayor and City Staff to transition when the Council decides it is appropriate.
  - Councilmember Rathe expressed that Councilmember Glaser will be missed. It has been a pleasure working with him and thanked him for his service on Council, for being on the Airport Commission, and for previously working with Hospice. Glaser, Rathe and Birgen have been invited to answer a 3-page list of questions from the lied center government class.
  - Councilmember Schneider shared his dog Maggie.
  - Guest Councilmember Quaicoe thanked Council for the opportunity to participate as a Guest Councilmember. He learned things at this meeting and looks forward to another meeting where he hopes to participate.
  - Councilmember Kangas reiterated that we are "all in this together" and looks forward to the parade making its way through town.

  - Mayor Hoffman shared that he had his lied center government class experience this day and found it very rewarding and added that Mr. Carlson was a great host. Hoffman also noted Pearl Harbor and the Tuskegee Airmen, the African-American soldiers that fought for equality first and also fought for our country. Councilmember Kangas added that Waterloo and Northeast Iowa contributed several members of the Tuskegee; they are also known as the Redtails which is why Hawkeye College named their athletic teams the Redtails.
