7. Description

This single-family house is estimated to have been built in 1900 according to Bremer County Assessor records. The house form and style are consistent with similar houses in Waverly built using this form from the end of the Civil War through the turn of the early 20th century. Both the 1899 and the 1913 city directory show a 2nd Street SE address occupied by the Hoover family. Property Transfer Records show H.S. Hoover as the first owner of Lots 7 and 8 at an unspecified date prior to 1904. Given Hoover's occupation in real estate, it is possible given this house's form that it was built as early as ca. 1899 or earlier or as late as ca. 1910.

This frame house is an example of a vernacular Gable Front and Wing, 2-story house form. The house has a parged block foundation with medium-width clapboard-style vinyl siding. The house has an L-shaped plan with an intersecting gable roof with narrow eaves and single hipped and shed roofed dormers on the east and south slopes. The design of the dormers suggests one or both may be additions. The original open porch that was tucked in the right-hand ell is now enclosed with a vinyl clad balustrade and a continuous row of 1/1 windows above. The biggest change to the house's original design is the addition of a 2-story shed roofed addition on the front façade, south of the porch in front of the front-gable wing. It has staggered single casement windows on each level of the front, and a pair of casement sash on the lower level of the south side. Fenestration for the house includes widely spaced 1/1 double-hung windows.

The property has two outbuildings. A 2-story "city barn" or carriage house is located along the alley near the rear of the property with the gable ends facing east and west. It is clad in synthetic clapboard-style siding and has 6-light sash in the gable peaks. The second building is a newer detached frame garage that has vinyl siding that matches the house, a low-pitched combination front-gable and shed roof, and a single double-wide overhead door. This garage also sits parallel to the east-west alley. According to Assessor records, the garage was built in 1935.

Alterations: vinyl siding (undated); garage modifications(undated); front 2-story addition (undated); porch enclosure (undated) .

8. Significance

The Hoover House at 316 2nd Street SE was built in ca. 1900 (or earlier) and is an example of a Gable Front and Wing, 2-story house form. Its owner-occupant at the turn of the 20th century, Henry S. Hoover, was employed in the real estate business. The house qualifies for the National Register of Historic Places as a contributing resource to the historic district under Criterion C.

By the turn of the 20th century, Henry S. Hoover and his wife Cecilia owned Lots 7 and 8 in Block 17 of the Original Town Plat. The 1899 city directory lists Henry as employed in real estate. Henry immigrated to Waverly in the 1850s and returned to his native state of Pennsylvania to marry his wife Cecilia Child in 1859. A brief biography of Henry taken from the 1883 *History of Bremer County* appears on the following page.

"H. S. HOOVER was born in Fayette County, Pennsylvania, on the 17th day of December, 1827. He is the son of J. HOOVER, who in early life learned the trade of a blacksmith, which he followed for some time, afterwards turning his attention to farming. In politics he was an old line Whig, and was an active worker in the campaign of General Harrison. He married Miss Catherine STOUFFER, by whom there was four children, three sons and one daughter, all of which are living at the present time. They were married in 1819, and lived together for sixty years, save a few months. Mr. HOOVER being the first death in the family. The sons are all living, married, and but two deaths have occurred in all the families. Mr. HOOVER died December 18, 1878, at the advanced age of eighty. Mrs. HOOVER followed April 30, 1879. The subject of this sketch was reared on a farm, receiving his education principally in his native county. When seventeen years of age he commenced teaching school, which he followed for a number of years. In the fall of 1856, he left his home in Pennsylvania and came to Iowa, locating in Waverly, where he was soon after employed in book-keeping for the firm of Hazlett & Company. In 1856, he was appointed a deputy county surveyor. In August, 1857, he was elected to this office which he has held since with the exception of four years. In the fall of 1859, he returned to his native State, when he married Cecilia CHILD, a daughter of William and Susan CHILD. By this union there are three children, one son and two daughters - Elmer E., Miriam C., and Kate. In politics Mr. HOOVER is republican, taking an active interest in all the issues of the day. He is also an ardent supporter of the temperance cause. The family are members of the Episcopal Church. "

Henry died in 1910 but Cecilia continued to reside here as a widow in 1913. She died in 1918 and both she and her husband are buried in Harlington Cemetery in Waverly.


