

RESOLUTION 20-12

A RESOLUTION APPROVING THE MAXIMUM PROPERTY TAX DOLLARS REQUESTED FOR FISCAL YEAR JULY 1, 2020 - JUNE 30, 2021

WHEREAS, at the January 27th, 2020 City Council Study Session meeting, the Waverly City Council approved setting a public hearing for February 17, 2020, on the maximum property tax dollars requested, and

WHEREAS, notice of said hearing was published as required in the Waverly Democrat and posted on the City website and Facebook on February 6th, 2020, and

WHEREAS, said hearing concerning the proposed city maximum property tax dollars was held on February 17, 2020, and

WHEREAS, the City Council of the City of Waverly have considered the proposed FY 2020/2021 maximum property tax dollars for the affected levy total, and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Waverly, Iowa, that the maximum property tax dollars for the affected tax levies for FY 2020/2021 shall not exceed \$4,945,094.00.

The Maximum Property Tax dollars requested in the total maximum levy for affected property tax levies for the FY 2020/2021 does not represent an increase of greater than 102% from the Maximum Property Tax dollars requested for FY 2020/2021.


